DIRECTIONS for USE:

Some settling may occur after extended periods of storage. Always mix/stir thoroughly before use. The produce has been filtered at the time of manufacture; however, separate filtration for critical systems should be used to avoid plugging of very small orifices. Do not store diluted produce in equipment - use all that you mix within 8 hours.

Application Rates:

Broadacre Crops: 10 L (2.5 usg) per acre in trench (min. dilution 1:2, 1:4+ preferred) at planting.

Transplants/fertigation: Dilute 1:100 for soil drench water or bi-weekly fertigation of starter plants (use within 8 hrs).

Continuous fertigation: Dilute 1:1000 (use within 8 hrs). Foliar/fertigation: up to 2 gal/acre (min1:10 dilution)

STORAGE:

Store out of direct sunlight. Freezing will not damage the product but will amplify the separation of components and settling, resulting in additional effort to thoroughly blend the produce again before use. Cold product is thicker and more difficult to mix/transfer. Keep containers closed when not in use.

CAUTION:

Keep out of reach of children and pets. Do not inhale or ingest. Avoid contact with skin, eyes, & clothes. If contact is made, flush eyes with water, clean skin, or wash clothes.
